FDA urged to crack down on firms shipping abortion pills to US from India

LALIT K JHA Washington, May 15 A BIPARTISAN GROUP of 117 lawmakers has urged the US Food and Drug Administration (USFDA) to crack down on companies, primarily based in Europe, that ship chemical abortion drugs from India to the US.



The lawmakers said in a letter to the FDA that the companies, primarily based in Europe, were distributing Mifeprex, a chemical abortion drug, by mail-order to US customers in violation of the FDA's safety protocols
