



Inaugural Formula E race in India made economic impact of nearly Rs 700 crore

HYDERABAD: Formula E's first-ever race in India, held in February earlier this year, made an economic impact of nearly Rs 700 crore, according to a report. The economic study conducted by Nielsen Sports Analysis calculated an USD 83.7 million (Rs 693 crore approximately) uplift to Hyderabad's economy as a result of the ABB FIA Formula E World Championship's debut race in Hyderabad on February 11.

Indian women's compound team shocks champions Colombia, enters final

BERLIN: India's compound women's team comprising Jyothi Surekha Vennam, Parneet Kaur and Aditi Swami jolted defending champions Colombia 220-216 to enter the



final of the ongoing archery World Championships on Wednesday. However, Indian hopes in the compound men's and mixed team events ended after tight defeats. In the men's event, Abhishek Verma, Ojas Deotale and Prathamesh Jawkar went down in the quarterfinals to Netherlands 230-235. In the mixed category, Deotale and Jyothi Surekha were pipped by the USA 154-153 in the round of last-eight. Earlier, Indian archers failed to secure Paris Olympics team quota places after making quarterfinal exits in both men's and women's recurve events. The tournament offers first tickets to the next year's Olympics for the top-three finishers in team and individual events.

India's Sanjana wins gold in clean and jerk

GREATER NOIDA: India's Sanjana won a gold medal in clean and jerk but settled for a silver in the total lift in women's 76kg category in the Asian Youth and Junior Weightlifting Championships here on Wednesday. Sanjana also won a silver in the snatch with an effort of 86kg in the youth competition. She lifted 112kg in clean and jerk to pick up a gold medal.

Four Indian javelin throwers qualify for World C'ships

NEW DELHI: In a rare instance in Indian athletics, four men's javelin throwers from the country have qualified for the World Championships in Budapest, Hungary, later this month, but injury to one member of the quartet meant that all of them will not take part in the big-ticket event. Olympic champion Neeraj Chopra has already qualified for the August 19-27 showpiece as wild card by virtue of being the Diamond League champion and Kishore Jena also made the cut in the world ranking quota. Rohit Yadav and DP Manu also made it to the 36 javelin throwers' list to compete in the world championships. But Rohit had recently undergone a surgery on his throwing elbow and he will miss the World Championships.

Sindhu, Srikanth, Prannoy enter second round

SYDNEY: Unheralded Indian Mithun Manjunath stunned fourth seed and world number seven Kean Yew Loh of Singapore in the opening round while PV Sindhu and Kidambi Srikanth secured straight-game wins at the Australia Open badminton tournament here on Wednesday. Manjunath, ranked 50th in the world, beat Loh 21-19 in the men's singles first round match that lasted 41 minutes. Manjunath faces the winner of the match between Lee Zii Jia and Leong Jun Hao — both Malaysians — in the second round of the BWF Super 500 tournament. Meanwhile, Lakshya Sen conceded his men's singles match against compatriot Kiran George due to an injury.

Diani scores a hat trick as France beats Panama 6-3

SYDNEY

Kadiatou Diani scored a hat trick as France advanced to the knockout stage of the Women's World Cup on Wednesday after a 6-3 win over Panama.

The world's No. 5-ranked team recovered from the shock of going behind to Marta Cox's 30-yard (meter) free kick after two minutes at Sydney Football Stadium to finish atop Group D. Jamaica placed second in the group after a 0-0 draw with Brazil.

France, which had also been held to a 0-0 draw against Jamaica in its opening game, advanced after back-to-back wins against Brazil and Panama.

The French only needed a draw to guarantee their place in the round of 16 for the fourth time in succession. But France was given an early scare when Cox whipped the ball into the top corner, beyond the reach of goalkeeper Pauline Peyraud-Magnin. France responded impressively to that early setback by going into the break with a 4-1



lead. Panama's Deysire Salazar lashed the ball into her own net when trying to clear Maelle Lakrar's header in the 21st. Diani scored her first goal seven minutes later, and converted from the spot in the 37th after a handball.

Lea Le Garrec's made it 4-1 in the fifth minute of first half stoppage time.

Diani scored her second penalty seven minutes after the break after another handball. Panama, ranked 52nd by FIFA, pulled a goal back with a penalty, converted by Yomira Pinzon in the 64th.

Sweden win Group G to advance to showdown with the United States

HAMILTON (NEW ZEALAND)

Rebecka Blomqvist's second-half goal lifted Sweden to a 2-0 win over Argentina on Wednesday to advance the Blagut to a round-of-16 showdown with the United States in the Women's World Cup. Argentina was eliminated from the tournament.

Neither side looked close to scoring for much of the match until Blomqvist broke the deadlock with a headed goal at the 66th-minute mark to help the blue and yellow finish 3-0 and win Group G. Sweden, which rested nine starters to open the match, threatened at times in the first half. A combination of disjointed play and fouls prevented Sweden from taking early control of the game.

Playing at times in a pelting rain, Argentina did not create a real chance in open play, and suffered a blow when veteran Florencia Bonsegundo was stretched off in tears after a late tackle by Blomqvist

in the 41st minute.

Late in the match, Gabriela Chavez committed a foul while defending a corner kick. Elin Rubensson converted the penalty kick in stoppage time to seal the victory for Sweden. Swedish



captain Caroline Seger made her 20th Women's World Cup appearance Wednesday to equal Hedvig Lindahl's tournament record for Sweden. Over 17,900 spectators packed Waikato Stadium, which holds just 18,009. The crowd was full of Argentina supporters who sang and chanted for all 90 minutes, plus stoppage time, on a brisk night in Hamilton.

Kgatlana scores late to send South Africa into the last 16 over Italy

WELLINGTON (NEW ZEALAND)



Thembi Kgatlana scored early in stoppage time Wednesday to give South Africa a 3-2 win over Italy and

send it into the knockout rounds of a Women's World Cup for the first time.

On a night of high drama and low temperatures, Hilda Magaia scored in the 67th minute to put South Africa 2-1 ahead before Arianna Caruso equalized with her second goal of the match from a Cristiana Girelli corner, briefly denting South African hopes. A draw would have been enough to put eighth-ranked Italy into the knockout rounds. Instead, South Africa will play Netherlands in a round of 16 match on Sunday. Sweden finished atop Group G after beating Argentina 1-0 and will next play the defending champion U.S. team.

Neeraj Chopra's phone call leaves Pakistan javelin thrower Yasir elated

KARACHI: Muhammad Yasir, the young Pakistani javelin thrower, is ecstatic after receiving a phone call from Neeraj Chopra, India's Olympic gold winner, congratulating him on winning a bronze medal in the Asian Athletics Championships. Yasir achieved the feat with a throw of 79.93 meters during the event in Bangkok last month. "It was a pleasant surprise when he (Neeraj Chopra) called me up and appreciated my performance after I won the bronze medal in the javelin event recently. He wished me best of luck for future events," Yasir told Geo TV. While India took home 27 medals including six gold and 12 silver from the Asian meet, Pakistan's only medal came through Yasir. Pakistan's top javelin thrower Arshad Nadeem didn't take part in the championships due to a long-standing injury problem.

Jamaica hold Brazil 0-0 to advance knockout round for the first time

MELBOURNE (AUSTRALIA)

Jamaica held Brazil to a 0-0 draw Wednesday and advanced to the pre-quarters of the FIFA Women's World Cup 2023 for the first time.

After conceding 12 goals in its Women's World Cup debut in 1999, Jamaica shut out France, Panama and Jamaica in consecutive games to book an improbable place in the tournament's knockout stage. It's the first time since 1995 that Brazil has failed to advance out of the group stage.
