NEW DELHI: A 3-year-old girl was allegedly raped by two men in south Delhi's Fatehpur Beri on Friday, police said. The accused, hailing from MP, were arrested. The accused lived in the same neighbourhood. The duo took the child to a nearby jungle and raped her. According to police, the girl was playing outside her house when the accused, who were consuming alcohol, spotted her. The child was rescued when another girl heard her cries and rushed to the spot. She then took the victim to the latter's mother.

Fire breaks out near Vaishno Devi shrine

JAMMU: A minor fire was reported in a temporary shed nearly a km away from the Mata Vaishno Devi shrine atop Trikuta hills in Reasi district of Jammu and Kashmir on Friday, officials said. The fire was brought under control by security personnel and the incident had no impact on the pilgrimage which is going on smoothly, they said. Some labourers were putting up at the temporary shed near the horse stand enroute to Bharav Ghati and some of their belongings caught fire at around 1.30 pm. Fire and emergency services, police, CRPF and shrine board employees swiftly put out the fire, they said.

Samyunkt Kisan Manch threatens agitation

SHIMLA: The Samyunkt Kisan Manch has taken strong exception to the Centre's move to cut funds under the Market Intervention Scheme, and threatened to launch an agitation if the budget for the scheme is not raised to Rs 5,000 crore. "The Union government has betrayed apple growers of Himachal Pradesh, Uttarakhand and Jammu and Kashmir by reducing the budget under the Market Intervention Scheme (MIS) from Rs 1,550 crore last year to just Rs I lakh in the Union Budget 2023-24 budget," a statement issued by the Manch said.

Punjab cabinet approves new industry, EV policies

CHANDIGARH: The Punjab Cabinet under the chairmanship of Chief Minister Bhagwant Mann approved new industrial and electric vehicle policies here on Friday, Finance Minister Harpal Singh Cheema said. Talking to media, Cheema said that the Punjab Electric Vehicle Policy and the new Industrial Policy, both have been approved in the cabinet. The approval of both the policies comes days ahead of an investors' summit to be organised by the state government on February 23-24 in Mohali

Liquor, fuel to cost more; social security cess levied

Petrol, diesel and liquor are to cost more in Kerala as the Left government imposed Social Security Cess on their sales as a way to mobilise additional revenue in the state budget presented here on Friday. While presenting the budget for the fiscal 2023-24, Finance Minister K N Balagopal said it is proposed to levy a Social Security Cess at the rate of Rs 20 for each bottle of IMFL having MRP between Rs 500 and Rs 999.

The cess would be levied at the rate of Rs 40 per bottle of IMFL having MRP above Rs 1,000, he said.

"An additional revenue of Rs 400 crore is expected through this," he said. Another impetus measure towards the Social Security Seed Fund is proposed to be brought by bringing the Social Security Cess on sale of petrol and diesel at the rate of Rs two per litre, he added.

"This is expected to bring in additional revenue of Rs 750 crore to the Social Security Seed Fund," he said.

'JANA THA JAPAN, PAHUCH GAYA CHEEN'

NEW DELHI: The Directorate General of Civil Aviation (DGCA) has ordered an inquiry after a passenger who was supposed to take an Indigo flight to Patna instead boarded another flight of the airline and landed at Udaipur - about 1400km away from his destination. The incident was reported on January 30 (Monday), and the passenger was sent to his destination next day.

A senior DGCA official said that the passenger, identified as Afsar Hussain, booked a ticket for Patna via Indigo flight 6E-214 and reached Delhi airport on January 30 to board the scheduled flight. But he mistakenly boarded Udaipur-bound flight 6E-319 of Indigo. The passenger realised the mistake only after landing at Udaipur Airport. After which he informed officials at Udaipur Airport, who then alerted the airline about the matter. The airline reportedly flew him back to Delhi the same day and then to Patna on January 31.


