# STF seizes Rs 70L from flat, believes it is hawala money

The Special Task Force raided an office in a building in Jaora Compound from where hawala operation was taking place and seized Rs 70.1 lakh. Seven persons, all from Gujarat, were arrested. Their nine mobile phones

and three currency note counting machines were also seized. During the raid, the STF officers found a secret chamber in the office, possibly for keeping cash.

SP (STF) Manish Khatri said they received a tip-off that some people were running hawala operations from an office situated on

the third floor in Nakoda Apartment in Jaora Compound.

The STF team raided the office and caught seven persons named Rajendra Patel of Ahmedabad, Suresh Solanki of Ahmedabad, Ajay Singh Solanki of Mehsana, Mehul Dave of Patan, Bhadra Singh of Bhavna-

gar, Sharad Bhai Rathore of Somnath and Vijay Bhai Lohiya of Somnath from there. All of them are being questioned further for their links.

They were allegedly involved in hawala operations as they could not present any document or receipt to account for the huge cash in the office.

Accused named Nitin wanted to forcibly occupy the hut and he had an argument with Kailash, and soon Nitin, his accomplices Sachin and Mohammad Ashfaq attacked Kailash.

## 5-YEAR-OLD KID DIES AFTER FALLING DOWN ON THE FLOOR; NO INJURY MARKS ON BODY

In a tragic incident, a five-year-old child died after he fell down on the ground while playing with other children in the Azad Nagar area on Monday evening. His kin informed the police that he was holding his one-and-a-half-year-old brother when he lost his balance and fell down on the ground. However, the police said that no injury marks were found on his body. The autopsy and viscera reports are awaited to ascertain the exact reason for his death.

The deceased has been identified as Ahmad Raza Khan, 5, a resident of the Madina Nagar area of the city. He was found rushed to hospital, but he could not be saved. His family members informed the police that Ahmad was holding his younger brother while playing with other children of the colony when he lost his balance and fell down on the ground and was injured. However, the younger brother did not sustain any injuries in the incident. After the accident, his body was sent for an autopsy.

Investigating officer S-IMK Tiwari from the Azad Nagar police station

said that no injury marks were found on the child's body, so, it was not yet established that the child had died after falling down on the ground. However, the autopsy report is awaited. To know the exact cause of death, the viscera were also preserved and the report is awaited.

The members of his family informed the police that someone had made a video of the incident on a mobile phone. The police are also checking the video. The child's father is differently abled and he was at home during the incident. The statements of the child's parents are being taken down by the police.
