Haryana passes bill on 75% job quota for locals

CHANDIGARH: Emulating the Himachal Pradesh government, the Haryana government on Thursday passed a Bill in the legislative assembly that provides a 75 per cent quota in private sector jobs to people belonging to the state. The Bill enables private companies, societies, trusts and partnership firms located in the state to follow 75 per cent quota that was the main demand of the Jannayak Janta Party (JP), a coalition partner with the BIP-led government.

"This unilateral decision by Pakistan is highly condemnable and runs against the spirit of the Kartarpur Sahib Corridor as also the religious sentiments of the Sikh community at large. We have received representations from the Sikh community expressing grave concern at this decision by Pakistan targeting the rights of the minority Sikh community in Pakistan," the MEA spokesperson Anurag Srivastava said. "Such actions only expose the reality of the Pakistani government and its leadership's tall claims of preserving and protecting the rights and welfare of the religious minority communities. Pakistan is called upon to reverse its arbitrary decision to deprive the Sikh minority community it's right to manage affairs of the Holy Gurdwara Kartarpur Sahib," he added. The move by Pakistan's government comes days ahead of the first anniversary of the inauguration of the historic Kartarpur Corridor on November 9. The 4-km long corridor links Dera Baba Nanak shrine in Gurdaspur in India to Gurdwara Kartarpur Sahib in Pakistan.

"Students of all research programmes and post-graduate students in science and technology programmes may join as the number of such students is comparatively less and norms of physical distancing and preventive measures can be easily enforced." 'Right to religion includes right to convert'

Plea in SC seeks setting aside the Allahabad HC order

A plea has been moved in the Supreme Court on Thursday seeking setting aside of an Allahabad High Court order, which held that conversions just for the sake of marriage are invalid. The plea said the Constitution provides for right to freedom of religion and also right to convert into any religion as many times

as one wants to with no tabs. The plea filed by advocate Aldanish Rein said the High Court order has laid a wrong precedent that the inter-religious marriages cannot be solemnised at the instance of conversion of religion by either of the partner. In the order passed on September 23, the High Court had declined police protection to a married couple in a case where a Muslim girl had converted to Hinduism and married a Hindu boy.

"The Chief Minister of Uttar Pradesh citing the above order of the High Court of Judicature at Allahabad raised the issue of "love jihad", and invoked "Ram naam satya" - a Hindu funeral chant, thereby threatening couples of Inter-religious Marriage", said the plea.

The plea said the High Court order has left the poor couple at the mercy of the offending family members, the police, the vigilantes and the hate monger religious associations.

The plea has argued that the Constitution provides for right to freedom of religion and the same includes that a person has the right to choose and profess any religion or no religion at all. "It also includes the right to convert into any religion as many times as one wants to with no tabs. Choice of religion is a personal choice of a person. If the Court does not allow a person to freely choose his religion, it amounts to a violation of his or her fundamental right", contended the plea.

Will contest in **2021 Assembly** polls: Kamal Haasan

assembly polls next year. Kamal Haasan said he is discussing politics with Rajinikanth who is also mulling to float a political party.

The MNM founder said he would also ask Rajinikanth for support in the upcoming polls.Kamal Haasan said it is Rajinikanth who has to take a decision on his political stance and his health is more important. According to Kamal Haasan, MNM's politics will not be blaming politics or vengeance politics but a guiding politics. He said the process of selecting the prospective candidates for the assembly polls is underway.

Kejriwal imposes ban on firecrackers in Delhi till Nov 30

Delhi Chief Minister Arvind Kejriwal on Thursday held a review meeting on the coronavirus situation and the preparedness of Delhi to deal with the COVID-19 cases and also decided to ban firecrackers, as both pollution and Covid-19 are adversely impacting city residents.

"The Delhi government has decided to put a complete ban on the sale, purchase, and use of firecrackers in Delhi from November 7 to November 30."

"The government has also decided to increase targeted testing at crowded places across Delhi, such as markets, mobile testing vans will be deployed in markets and crowded places across Delhi. The testing can be availed free of cost by the people at these places," he said.

'All insults against SC/STs can't be termed as offence under SC/ST Act'

New Delhi

The Supreme Court on Thursday said that an offence under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act is not made out on the fact that the complainant is a member of SC or ST.

A bench comprising Justices L. Nageswara Rao, Hemant Gupta and Ajay Rastogi said: "All insults or intimidations to a person will not be an offence under the Act unless such insult or intimidation is on account of victim belonging to Scheduled Caste or Scheduled Tribe."

The bench emphasised that the object of the Act is to improve the socio-economic conditions of the Scheduled Castes and Scheduled Tribes as they are denied a number of civ-

"Thus, an offence under the Act would be made out when a member of the vulnerable section of the society is subjected to indignities, humiliations and harassment," added the bench. The top court said that it is essential to establish that there is an inten-

The Group has determined 'Snacks Food' as a reportable segment as evaluated by the chief operating decision maker for allocation of resources and assessing the performance. There are no other reportable segment as per Ind AS 108 'Operating Segment'. Accordingly, no separate segment information has been provided. In accordance with the requirements of Ind AS 16 "Property, Plant and Equipment", the Group has reassessed the useful life of property, plant and equipments and has revised the estimated useful life of plant and machineries to 15 years from the existing useful life of 10 to 21 years on the basis of technical evaluation carried out by the management's expert. The effect of the said change is recognised prospectively w.e.f. 1 July 2020 as per the requirements of Ind AS 8 "Accounting Policies, Changes in Accounting Estimates and Errors". Consequent to this change, depreciation and accumulated depreciation is lower and net profit before tax is higher by INR 326.49 lakhs for the quarter and half year ended 30 September 2020. Further, the balance of other equity is higher by INR 248.12 and basic and

diluted earnings per share (not annualised) is higher by INR 1.06 as at and for the guarter and half year ended 30 September 2020. During the guarter ended 30 September 2020, the Holding Company has distributed dividend @ INR 1 per share amounting to INR 234.53 lakhs as approved by

shareholders in its annual general meeting on 18 September 2020 for the financial year 2019-20. On account of the spread of COVID-19 virus, the Government of India had imposed a complete nation-wide lockdown on March 24, 2020 leading to shut down of the Group's manufacturing facilities (including contract manufacturing facilities) and operations. During the quarter, the Group has resumed operations at all its manufacturing facilities and is currently in the process of scaling up its operations. As the products manufactured by the Group are covered under essential services, the impact has been less significant. Management believes that the pandemic is not likely to impact the recoverability of the carrying value of its assets. Management is closely monitoring the developments and possible effects that may result from the current pandemic on its financial condition, liquidity and operations and is actively working to minimize the impact of this unprecedented situation. As the situation is continuously evolving, the eventual impact may be

different from the estimates made as of the date of approval of these consolidated Ind AS financial results.
