# Chinese tech firms censor Uyghur, Tibetan languages

Beijing: Chinese tech companies appear to censor Uyghur and Tibetan by removing their languages from study courses as well as banning comments in them from their websites. Public concerns about tech-enabled suppression of ethnic minorities have deepened, reported Protocol. As per Talkmate, a languagelearning app that partners with UNESCO, posted via its official Weibo account that it had "temporarily" taken down Tibetan and Uyghur language classes "due to government policies." This announcement was posted last Friday but appears to have been removed. The app, which appears to champion linguistic diversity, offers courses in nearly 100 languages, from Urdu and Montenegrin to Creole and Slovak, reported Protocol.

# Taiwan rejects Beijing's 'one China' principle

Taiwan on Thursday slammed Beijing for its 'interference' in the internal matters of the democratic island after the Chinese Communist Party said that Taiwan's participation in Asia-Pacific Economic Cooperation (APEC) activities must be based on the 'one China' principle.

"China's false statements have severely undermined the spirit of APEC," the Taiwan Ministry of Foreign Affairs said adding that China should stop "improper political operations" and interference with Taiwan's participation in **APEC-related meetings.** 

The developments came a day after Beijing's Taiwan Affairs spokesperson, Zhu Office



Fenglian said that the "Taiwan APEC activities must be based on the "one China" principle, region's" participation in

Dastan in the past.

Taiwan News reported.

"Since Taiwan joined APEC in 1991, it has participated in the economic and trade forum as a full member," the Taiwan Ministry of Foreign Affairs (MOFA) said in a statement.

"Taiwan enjoys the same status and has the same obligations as all members. There is no 'one China' principle in the agreement allowing Taiwan's participation in APEC," MOFA was quoted as saying by Taiwan News.

The ministry also said that it rejects China's attempts to distort historical facts and demand acceptance of the "one China" principle to "create the illusion" that Taiwan is subordinate to China.

Taiwan is not a part of China and that the Chinese Commu-

nist Party has never ruled Taiwan for even one day. China has no right to represent Taiwanese on the international stage or anywhere else, Taiwan News reported citing MOFA.

"Only Taiwan's democratically elected government has the right to represent the 23.5 million Taiwanese," MOFA said.

This came as Beijing claims sovereignty over the democratic island and has increased military incursions in Taiwan. Taiwan is a democracy of almost 24 million people located off the southeastern coast of mainland China.

Despite being governed separately for more than seven decades. China has threatened that "Taiwan's independence" means war.

#### Indian-origin techie sentenced to life by US court for killing family

LOS ANGELES: Shankar Nagappa Hangud, an Indian-origin IT professional in the US who dramatically confessed to killing his wife and three children in 2019 in a week-long crime spree, has been sentenced to life in prison without parole. Investigators said Hangud, 55, confessed to killing his wife and three children over several days at his apartment in California, saying he could not provide for them financially, KCRA-TV reported on Wednesday. He declined to comment during sentencing in Placer County, the report said. Hangud made national headlines after walking into the Mount Shasta Police Department, 320 kilometres north of Roseville, telling officers he had killed four people.

#### Magnitude of 6.1 earthquake jolts Indonesia, no reports of damages

JAKARTA: A 6.1-magnitude earthquake jolted Indonesia's province of West Papua on Thursday, but no preliminary report on damages or casualties was issued, the meteorology agency said. The tremors did not potentially trigger a tsunami, according to the country's Meteorology, Climatology and Geophysics Agency. The quake occurred at 12.46 a.m., with the epicentre at 115 km southeast of Kaimana district and the depth at 14 km under the seabed, the agency said. The jolts of the quake were not felt, according to the agency.

### 3,000-yr-old Indian poetry translated into Arabic

SHARJAH: The Arabic version of a book containing 3,000-year-old Indian poetry was launched at a private ceremony on the sidelines of the Sharjah International Book Fair (SIBF). "100 Great Indian Poems" is an anthology of 28 poems in 28 languages including Kashmiri, Bengali, Tamil and Urdu and boasts the works of legendary Indian poets like Mirza Ghalib and Firag Gorakhpuri. "Some of the poems in the book are as old as 3,000 years," said Abhay Kumar, the Indian Ambassador to Madagascar, who edited the book that was first published in 2018 and then translated in various languages (Portuguese, Italian, Spanish, Malagasy, French, Irish and Nepalese). -Agencies

The Duchess of Sussex, Meghan Markle, apologised to a UK court after admitting being involved in a biography of her short tenure as a royal in Britain, despite having previously denied it. 

A prominent Hindu organisation is facing new allegations in an updated lawsuit that it lured labourers from India and forced hundreds of workers to work for low wages at its temple sites across the United States. In May this year, a group of Indian workers had filed a lawsuit in US District Court alleging violations of human trafficking and wage law against Bochasanwasi Akshar Purushottam Swaminarayan Sanstha (BAPS), saying they were confined and forced to work for about USD 1 on constructing the massive Swaminarayan temple in New Jersey.

The New York Times said in a report on Wednesday that in the lawsuit filed in New Jersey federal court and amended last month, BAPS has been accused "of luring labourers from India to work on temples near Atlanta, Chicago, Houston and Los Angeles, as well as in Robbinsville, New Jersey, paying them just USD 450 a month."
