42,399 PEOPLE VACCINATED

People waiting for 1st dose can receive the shot today

As many as 42,399 people were vaccinated on Wednesday with the second dose of Covishield and Covaxin. People waiting to get the first dose of vaccine can take the dose on July 8 and July 10 as the department has got over 52,000 for the next drive.

"We vaccinated people with the second dose of Covaxin and Covishield on Wednesday and some were also vaccinated with the first dose. People can get the first dose of vaccine only from July 8, while we continue ad-

A large number of people who reached the vaccination sites had to return disappointed as they wanted to take the first dose, but it was not available at most centres across the city. The staff manning the vaccination centers had to inform people to come back on July 8 to get their first jab, while many people had to wait due to mismanagement at the centres.

Married woman found hanging in the kitchen

Indore: A married woman allegedly committed suicide by hanging herself from the ceiling at her home in the Pardeshipura area on Wednesday. She was mentioned in the suicide note that she was troubled due to her asthma. The police are taking down the statements of her husband and other family members. The deceased has been identified as Sonam Sen, 28, a resident of Ayodhya nagari, in the Nanda Nagar area of the city. She was found hanging by a member of her family between 4 am and 5 am. She was taken to hospital but could not be saved.

Pardeshipura police station-in-charge Ashok Patidar said that Sonam's parents live in Agra. A suicide note was recovered from the spot where she had mentioned that no family member should be troubled by the police.

Plea to restart DEMU service

Mhow: The Western Railway Ratlam Board wrote to officials in Mumbai to start Diesel Electric Multiple Units (DEMs) between Indore-Mhow-Ujjain-Ratlam, officials said on Wednesday. The train service was stopped due to the Covid-19 crisis, affecting the daily passengers. Because the service was stopped, people had to travel at a cost of Rs 60-Rs 80 for a round trip instead of the usual Rs 40- Rs 50.

Demolition drive at New Umariya

Mhow: A team led by SDM Abhilash Mishra conducted a demolition drive at New Umariya Colony on Wednesday. The team took action after a complaint of land fraud against coloniser Parwat Singh Thakur. It is alleged that the coloniser has not done a registry of the plot owners and also sold the same plots to multiple people. The team demolished some parts of the construction and warned the coloniser to resolve the issues of the people within one week.

3-year-old girl drowns in tank, contractor booked

Indore: A 3-year-old girl drowned in the underground water tank at an under-construction site in the MG Road area on Wednesday. Her parents were working at the site while the girl was playing near the tank when she fell into it. The police have registered a case of negligence against the contractor in the case. According to S-I Raghuvanshi from the MG Road police station, the incident took place at an under-construction site near Marathi School around 12.30 pm.
