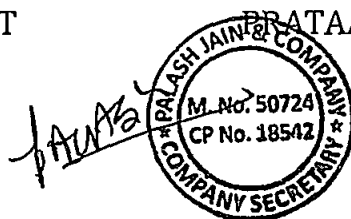

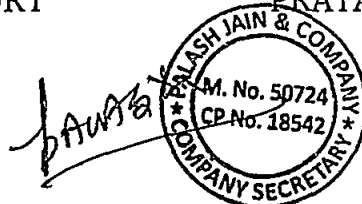

1. The Company had appointed Central Depository Services Limited (hereinafter referred to as the "CDSL") as the electronic voting agency for providing the facility for electronic voting.
2. CDSL had provided a system for recording the votes of the Equity Shareholders electronically through remote e-voting as well as e-voting at the meeting which was held on Friday, 12th August, 2022.
3. CDSL had set up remote e-voting facility at www.evotingindia.com. The Company had uploaded Notice of the meeting, inter-alia, containing the item of the business to be transacted at the meeting on the website of the Company and also its Service Provider and also on the websites of Stock Exchanges viz

4.
